

Pure Rewards Giveaway Terms & Conditions

For the purposes of these Terms and Conditions, "The Promoter" refers to Pure Networks whose LinkedIn Profile is Pure Networks and website is www.purenetworks.ie. The "Prize" refers to 3 nights hotel accommodation with breakfast in a double room, flights from Dublin to Bologna, and Grandstand tickets to the Italian Grand Prix. Due to the lack of regular flights from Dublin to Bologna, the return flight is an indirect flight with a short stopover.
